Tournament Rules

1. Life vest must be worn at ALL times while engine is running with kill switch attached.
2. Boating safety at ALL times.
3. All boats must be in the water 15 minutes to blast off.
4. No alcoholic beverages or drugs allowed.
5. No live bait.
6. No trolling.
7. All fish must be caught during hours of the tournament.
8. No mutilated or lake dead fish.
9. Minimum size limit is 15" with mouth closed, 15" for smallmouth, measured on a straight edge "Goldern Rule" (no belly boards used.)
10. Anyone late for weigh in will be penalized (1) pound per minute.
11. Five (5) fish limit per boat.
12. Smallmouth, largemouth & Kentucky bass only.

PARTICIPANTS AND ELIGIBILITY: This tournament is open to customers, employees and affiliates of Brandeis Machinery & Supply Company, and Atlas Copco and Komatsu. **Entry fee is \$100 per boat.**

SCORING: Winning shall be determined by the pound and ounce system. Both partners catch will be combined for total weight. Only Largemouth, Smallmouth, and Kentucky Spotted Bass are eligible for weigh in.

- 1) 5 FISH LIMIT PER BOAT.
- 2) MINIMUM SIZE 15 INCHES WITH MOUTH CLOSED, USING GOLDEN RULE.
- 3) 1 LB. PENALTY FOR EACH MINUTE LATE TO WEIGH IN SITE.
- 4) LIFE VEST MUST BE WORN AT ALL TIMES WHILE ENGINE IS RUNNING, WITH KILL SWITCH ATTACHED.
